  - If we are accredited, we be will be able to bill commercial insurance.

# **IDN UPDATE**

- The IDN meeting held on March 16th for COOS County in West Stewartstown to vote on funding, narrowly passed.
- All counties have now agreed to participate at 30% which is 20% less than planned.
- There will be a Legislative Breakfast on June 7<sup>th</sup> to help the legislators understand the work that is being done by the IDN group and keep them involved.
- The Board of Director suggested that the each Board member's website list the IDN with a link back to the IDN to help promote the IDN and the work.
- 3 MCOs in the State must work with the IDNs.
- Payment from the IDN is in arrears (since 2017). The Board suggested inviting Jeffrey Meyers, the Commissioner to the next Board meeting to understand why.
