Nancy announced that all 7 IDN regions have agreed on one IT platform called "PreManage" for which there is a fee associated with it. Ed Shanshala noted that if they can get the cost within the next 2 weeks, there is a grant available to help offset some of this expense.

#### Friendship House Update

- Nancy has the bridge contact. It needs signatures and needs to be returned by Monday. It will be on the G & C agenda in August
- Conversations with the Commissioner's office regarding the transfer of contracts have begun
- Established an internal transition team. Marylou Krambeer is assisting with facilitation
- Lawyers have been consulted regarding Transition Agreement with Tri-County CAP
- Nancy has been talking with like agencies regarding staffing; we will likely need to hire an operations director.
- Just waiting for USDA to approve the last piece of funding, then all the funding will be in place. With the current funding, the new building will be debt free.
- Transition date planned to be October 1, 2017.
- Ground breaking is scheduled for mid to end of August depending on funding.

# New Grant Awards

- NH DHHS 2-year contract to continue and expand Public Health Network/Substance Use Disorder programs \$946,538 over 2 years
  - This will allow us to expand our flu vaccine clinic, young adult substance use prevention in the workplace, mental health support during disasters in the north country.
- HRSA, Federal Office of Rural Health Policy Network Development Program \$300,000 each year for 3 threes
  - Support expansion of the CHW program for chronic disease and care coordination and the Live, Learn and Play program.

## **New Grant Opportunity**

- HRSA, Federal Office of Rural Health Policy Rural Health Opioid Program due July 21, 2017
  - This grant will be written to support SUD clinicians in emergency room as a warm hand-off for over dose patients as well as their families. Proposal will also expand the CHW roll as recovery support staff.

#### **NCHC Updates**

- An agreement with AHEAD has been made for the NCHC to expand into the office of North Country Council. This will likely happen in late fall
- Hired a person to be in the Berlin School but our employee to work on the Restorative Justice Program
- Have been asked by the Colebrook School District to hire an employee to assist with wrap around services.
- Looking into the possibility of hiring a director for the HRSA grant and a Finance/HR person.
