#### **New Funding Opportunities**

Grant: HRSA: Behavioral Health Worker, Division of Nursing and Public Health

Grant Period: 9/1/2017 – 08/31/2021

Grant Due Date: 6/12/2017

Approximately 75 % of the opportunity specifies full scholarship funding for Paraprofessionals and Professional Tracks to qualified applicants with a focus on behavioral health. NCHC will be the administrator of the grant.
