#### MGT-405 Mobilizing Faith-Based Community Organizations in Preparing for Disasters **Concord NH**

This eight-hour, planning and management-level course trains faith-based community organization (FBCO) representatives, management-level emergency managers, and first responders from small and rural communities to strategically mobilize and engage members of FBCOs, including religious charities, nonprofits such as the Salvation Army, the American Red Cross, churches (both affiliated and unaffiliated), temples, synagogues, mosques, and NGOs etc., in a reciprocal approach to disaster planning that is integrated into current local and statewide emergency management efforts. This course emphasizes grassroots mobilization and coordination efforts as a means of engaging all faith communities, thereby reaching those marginalized communities most vulnerable to disaster, most frequently excluded from the planning process, and ultimately, most difficult to aid in recovery.

The 8 hour ILERSBA course presents information on suicide bomber recognition and appropriate response categories, including tactical response. This course is designed to prepare law enforcement officers to recognize the threat of an active suicide bomber through the recognition of Suicide Bomber Improvised Explosive Device (SBIED) components and suicide bomber behavioral indicators. The course provides multiple response strategies to effectively interdict a suicide bomber. Additionally, the ILERSBA course teaches law enforcement officers how to establish response priorities when responding to a suicide bombing post-blast scene, given the unique hazards associated with such an incident. These jurisdictions must develop plans that address succession planning, redundant communications, and alternate site needs for their communities to face increasingly frequent threats. This tuition free course will expose participants to the benefits of developing continuity of government plans for rural communities with special focus on succession planning, delegation of authority, redundant communications, and alternate facilities.

The HME course provides first responders with information on general explosive characteristics and hazards, homemade explosive precursor materials, homemade explosive manufacturing indicators, and Improvised Explosive Device (IED) components. Additionally, the course teaches first responders how to identify a homemade explosive laboratory and how to establish scene safety and security in such an incident. First responders are also presented information regarding community awareness and education programs related to homemade explosives. This information better prepares first responders to recognize hazards associated with homemade explosives during response operations.

These trainings are being combined into a comprehensive two day course The Essentials of Community Cybersecurity (ECCS) course provides individuals, community leaders, and first responders with information on how cyber-attacks can impact, prevent, and/or stop operations and emergency responses in a community. The course also provides a cursory introduction to

cybersecurity vulnerabilities, risks, threats, and countermeasures. It explains vulnerabilities of computer systems and networks and how these vulnerabilities can affect communities, organizations, and daily workplace operations. The course introduces actions communities can take in establishing a cybersecurity program. Community Preparedness for Cyber Incidents, is designed to provide organizations and communities with strategies and processes to increase cyber resilience. During this 12-hour course, participants will analyze cyber threats and initial and cascading impacts of cyber incidents, evaluate the process for developing a cyber preparedness program, examine the importance and challenges of cyber related information sharing and discover low to no-cost resources to help build cyber resilience.

This performance-level course provides diverse agency representatives who have hazardous material backgrounds the ability to coordinate with local and state emergency responder agencies; to assess CBRNE events; conduct area surveys in a safe and effective manner; conduct material characterization and screening operations; and, collect public safety samples in a hazardous environment. This course provides participants with an opportunity to perform public safety sampling techniques required in the response to a CBRNE event. Of special interest is the course's emphasis on collecting forensically valid samples, which is accomplished through maintaining a secure chain-of-custody for the sample from the time of collection through laboratory analysis. This process is consistent with operations of all public safety responding agencies.
