#### **Opioid Grant**

Given the limited number of grants and competitive nature, NCHC was not awarded the opioid grant. High scores were reported in the review process.

## Friendship House/AoD Services Update

Nancy provided the following update on Friendship House:

- Lease agreements are in place with TCCAP and AHEAD. AHEAD closed on the building and land as of 10/12 and the lease now transition to AHEAD
- Staff are hired as NCHC employees effective 10/1/17
- Email addresses added for all staff and phones under evaluation
- We are working on the transition of patient records from TCCAP to NCHC.
- Looking for office space in Berlin, Woodville and Tamworth to move out of TCCAP facilities
- Bridge funding has requested a monthly report. The first month \$7,000 was spent
- NCHC has been approved as a provider for the Impaired Driver program
- Currently considering Executive Director and nurse position
- Nancy requested permission to sign contracts for the Friendship House

A motion giving Nancy authority to move forward to sign substance use services and engage in vendor contracts and licenses up to\$20,000 was made by Mike Lee. Scott Colby seconded the motion.
