#### North Country ACO, CCO, other ACO Updates

The North Country ACO board of directors voted not to submit a renewal application to CMS. The current contract will end December 31, 2015. All of the health centers that were members of the ACO participated in other ACO proposals. ACHS, ISHC, and CCFHS collaborated with LRH, AVH, UCVH, Cottage, Weeks and Monadnock Hospital to submit an AIM ACO proposal. Mid-State Health Center is planning to join an ACO in the southern part of the state. The CCO work is "on-hold" at this point, but will likely play a role in the future as a vehicle for contracting with commercial insurers.
