History and Purpose

The North Country Health Consortium (NCHC) is a rural health network, created in 1997, as a vehicle for addressing common issues through collaboration among health and human service providers serving Northern New Hampshire. NCHC is engaged in activities for:

- solving common problems and facilitating regional solutions
- creating and facilitating services and programs to improve population health status
- health professional training, continuing education and management services to encourage sustainability of the health care infrastructure
- increasing capacity for local public health essential services
- increasing access to health care for underserved and uninsured residents of Northern New Hampshire

Programs and Services

Workforce Development, Education and Training

The Northern New Hampshire Area Health Education (AHEC) is one of two federally designated AHECs in New Hampshire. Northern NH AHEC serves health and social service organizations and educational institutions in Coos, Grafton, Carroll and Belknap counties with the following programs and services. Community Substance Abuse Prevention (CSAP)

CSAP staff provides leadership, facilitation and coordination for individuals, agencies, and community coalitions to work together in the North Country to develop and implement substance abuse prevention activities. Assessment, training, evaluation, and communication strategies are used to strengthen substance abuse prevention initiatives in the North Country.

Coalition and youth-facilitated community-based activities are focused throughout Northern Grafton and Coos County. Activities are designed to reduce access to alcohol by youth and reduce abuse of alcohol, tobacco, and prescription drugs by youth.

Molar Express

A mobile public health dental clinic designed to provide dental services to North Country residents who experience barriers to accessing dental care in traditional dental practices. A particular emphasis is placed on providing services to Medicaid eligible children. Molar Express services are delivered in schools, nursing homes and community sites and include:
