Grant Opportunity

NH DHHS Regional Public Health Network Initiatives RFP discussed. NCHC was considering applying for one of the initiatives, "Community Readiness Assessments to Increase Access to Safe and Affordable Physical Activity." Molar Express Sustainability Plan

A Sustainability Plan is due for our Outreach Grant on February 14th. The Outreach grant currently provides funds for uninsured and undersinsured children to receive oral health care services. The grant ends April 30, 2015, although NCHC has applied for a new Outreach grant that would begin May 1. Funding awards will probably not be announced until April. The board discussed options for sustaining Molar Express and also discussed the question, "should be sustain Molar Express?" The board overwhelmingly supports sustaining Molar Express. Several potential resources and strategies were discussed to maintain the level of services currently provided.

The Network members that signed on to the original Outreach grant proposal agreed to sign off on the new/revised Sustainability Plan. The full Plan will be distributed to the board when it is complete.

New NCHC Member Application

Affordable Housing Education and Development (AHEAD), Inc. has applied for NCHC membership.

Adele Woods made a motion to approve AHEAD's membership; Mike Coughlin seconded the motion. Motion passed.

North Country ACO Update

FQHC and NCHC staff are working on the next round of quality measures that are due to CMS in March. Ken Gordon, ACO Administrator has resigned to take the CEO position at Coos County Family Health Services. Ken and Nancy Frank are working on a transition plan.

Board Development Discussion

Nancy Frank asked the board to consider the types of board development they may want over the next year. Several options were discussed for the board to consider to enhance the value of the board and board meetings. The board charged the Executive Committee with bringing back a proposal to the full board regarding a couple of potential new models for board meetings.
