Nancy expressed thanks to consortium team for health summit

Charlie/Sharon seconded accepting financial statements.

Charlie expressed thanks to consortium for enhancements to financial reporting and expects challenges with transition to continue.

New members: Sandy Olney, Rolanda – Charlie moved/elisa seconded

United Way discussion: consider the funder and very different approach to fundraising

Grant opportunities: Nancy discussed concern about rural concentration for program – statewide level poses challenge (pop. <500k)

Funds awarded based on population with a floor of \$110k

Is process worth the effort? How would our community benefit? (Nancy's concern)

Elisa: HEAL – healthy eating, active living (CDS funder)

Charlie: could nchcnh collaborate with another local effort and address tobacco issues?

Rosemary, Elisa: national level – could be multiple awards per state, 7 of 10 NH communities are rural

CSAP – tobacco 'could start tomorrow'

Charlie motion to move forward/Rosemary second

State required strategic plan for prevention network - \$1.5 million set aside to support prev. network based on strategic plan

Bob T.'s plan focuses on specific issues – 5 strategies

Plan submitted and each region may receive allotted, Sept. timeline with 10-year investment period State combining PH region and RPN, Prev. Coordinating position funded by state

Sharon – ACO update

Citizen's Health Initiative joined Board meeting in Concord NH, ACO 'project' (no longer 'pilot') AVH, Weeks, CVH, Littleton, Memorial, Cottage

Kevin scheduled and facilitated meeting

Challenges: weekly CMS call, young team in Washington, CMS still helpful and cooperative Some patients opting out, Mid-State ordered server, invited Center for HIth Analytics crew (Jo Porter)(Meghan Spencer) – Sharon confident about data uploading

Elisa requests place for presence, SPEAR – FTE Michelle to address transition

NC ACO contracted consortium to do accounting and management, as long as nchcnh staff ok handling with task load, Nancy has flexibility to formulate staff position as she deems most appropriate ACO separate from Medicaid managed care, CMS population attention will rollover to Medicaid managed care

10 hospitals in legal suit with state re: Medicaid funding

Charlie – Mgmt Svc Co finalized and co. starts 7/1/2012

Indian Stream recruited new physician, pediatrician starts in Aug., rec'd huge fed. Grant & Tillotson funds, 340b pharmacy program, expansion project for elevator
