#### **Grants Update**

## Rural Health Information Technology (HIT) Workforce Development Program

This is a grant to support formal rural health networks that focus on activities relating to recruitment, education, training and retention of HIT specialists. The grant provides support to develop the program. The grant is for \$300,000 each year for three years. NCHC will explore the possibility of partnering with White Mountains Community College.

## Strategic Prevention Framework Partnership for Success

This is an RFP put out by the state of NH to leverage the state's existing prevention system to work with schools in high priority areas to reduce substance abuse. The grant is for \$100,000 each year for two years.

## Staff Updates
