Consent Agenda

The consent agenda included:

Charlie White made a motion to approve the consent agenda; Ed Shanshala seconded the motion. Motion passed.

Ratify Approval of Form 990 – e-mail vote

Following the February board meeting recommended changes were made by the auditor to the Form 990 and sent via e-mail to the board. The board unanimously approved by e-mail and Form 990 was filed by the deadline.

Charlie White made a motion to ratify the e-mail vote; Sharon Beaty seconded the motion. Motion passed.

Investment Policy

The NCHC Investment Policy is reviewed every three years. It was last reviewed and approved in March 2011.

Charlie White made a motion to approve the Investment Policy without any change; Adele White seconded the motion. Motion passed.

Lease Renewal

NCHC's current lease ended February 28, 2014. AHEAD has purchased the building and agreed to extend the current agreement through April 2014 to provide time to negotiate a new lease. Charlie White made a motion to give the executive director authority to negotiate a new lease up to five years. Adele Woods seconded the motion. Motion passed.

North Country ACO Update (Community Care Organization discussion)

The North Country ACO has received the first year interim financial results. The ACO did not quite make the threshold of anticipated savings. There were 114 ACOs in the Shared Savings Program. Sixty did not achieve any savings, 29 reached shared savings, and 25, including the North Country ACO, had savings but did not reach the goal.

Four hospitals in the region, Littleton Regional Healthcare, Upper Connecticut Valley Hospital, Androscoggin Valley Hospital, and Weeks Medical Center, have formed a collaborative and are working together to establish an LLC. The hospitals, in conjunction with the federally qualified health centers, are also exploring models to create a Community Care Organization (CCO). NCHC and North Country ACO have been invited to participate in designing the conceptual framework for the CCO. The "design team" includes Ed Shanshala, Warren West, Kevin Stone, Nancy Frank, and Ken Gordon. The team plans to meet bi-weekly, and to share minutes with the larger CCO group. At this time the larger CCO group includes the CEOs of the hospitals and the FQHCs which are participants in the North Country ACO. CCO updates will be provided to the NCHC board each month. The board supports Nancy and Ken's participation on the design team.

Program Updates

Quality Improvement Program to Reduce Obesity in Rural Northern NH
Becky McEnany, Project Coordinator, provided an overview of the new project. This is the
grant NCHC was awarded from HRSA, Office of Rural Health Policy, Small Rural Health Care
Provider Quality Improvement Project, for \$150,000 each year for three years. The project has
three main focus areas: 1) offering quality improvement coaching using the Clinical
Microsystems model to the four FQHCs in the region; 2) training in Motivational Interviewing
for health center staff and community partners; and 3) development of an obesity "tool kit" for
clinicians, patients, and the community.

Shoot For The Moon

Shoot For The Moon is the Consortium's community challenge to walk to the moon (238,000 miles) by our next Health Improvement Summit, June 27, 2014. Many organizations, hospitals, health centers, schools are participating, but we have a long way to go! Organizations can easily sign-up through the NCHC website.

Oral Health Contract with Bi-State Primary Care Association

NCHC has entered into a contract with Bi-State in partnership with their federal grant, "Strengthening the Oral Health Workforce in Rural NH." This is a statewide collaborative initiative with NH DHHS, Mid-State Health Center, Ammonoosuc Community Health Services, University of New England, and Health First. NCHC is receiving \$14,500 for some mobile clinical supplies and staff training time.
