Grants/Funding Updates

Oral Health Collaboration

NCHC/Molar Express is part of a statewide federally-funded initiative with the State Office of Oral Health, Bi-State Primary Care Association, Mid-State Health Center, Ammonoosuc Community Health Services, and others, focused on increasing access to oral health care, and enhancing recruitment and retention of dentists to our underserved areas. NCHC will receive funding for additional portable equipment and consultation for our dental hygienist. *Navigator FOA*

There is an opportunity from CMS to receive funding for Navigator services related to the new health insurance Marketplace and Exchanges that will be implemented as a result of the Affordable Care Act. Bi-State has solicited their members to be part of their proposal. There will be \$600,000 available for the state, and at least two organizations will be awarded funding. If NCHC participates in Bi-State's proposal, we would like to coordinate the efforts in the North Country. A decision to submit our own proposal will depend on negotiations with Bi-State. *Rural Health Outreach Grant*

NCHC was told that the second year funding of our Rural Health Outreach Grant would be delayed due to sequestration. The grant period begins May 1st. We have now been told the funding has been approved and we will not experience the 2-3 month delay that had been discussed.

Rosemary Orgren Board Replacement

Rosemary Orgren is retiring and resigned from the Board of Directors. She recommended Kristina Fjeld-Sparks, who will become the Center Director of the NH AHEC Program, to take her place.

Adele Woods made a motion to accept Rosemary's resignation with regret and nominated Kristina Fjeld-Sparks to replace Rosemary for the remainder of her term; Sharon Beaty seconded the motion. Motion passed.

North Country ACO Update

Nancy Frank and Sharon Beaty will be attending a national Shared Savings Program ACO meeting in Washington on May 21st. There have been numerous data challenges working with CMS. The claims feed data from CMS has been delayed. The ACO will be reviewing and analyzing emergency room data and working on quality initiatives to reduce ER visits.
