August 2014 Financials

Colleen Gingue presented and reviewed the financials. Tony Poekert made a motion to approve the August 2014 financials; Gail Clark seconded the motion. Motion passed.

FY 2015 Organization-Wide Budget

Nancy Frank and Colleen Gingue presented and reviewed the proposed FY 2015 budget. The budget was built on 2014 actual costs. Proposed personnel costs include a 3% cost of living increase. The board thanked Nancy and Colleen for presentation of a "nice, clean budget." *Adele Woods made a motion to approve the FY 2015 organization-wide budget; Sharon Beaty seconded the motion. Motion passed.*

Grants/Funding Update

Rural Health Network Development Grant

NCHC was awarded this grant in September from HRSA, Office of Rural Health Policy. The grant provides support for workforce development initiatives. Strategies include: 1. Expand and enhance Live, Learn, Play in Northern New Hampshire; 2. Develop a model for a regionally-based Primary Care Extension Program; 3. Improve consumer utilization of the health care system through the use of Community Health Workers. The grant is for \$300,000 each year for 3 years.

Health Careers Opportunity Program – Skills Training & Health Workforce

NCHC was also awarded this grant in September. This grant is a partnership with White Mountains Community College to provide paraprofessional careers opportunities. The initiative will provide 100% support for 79 economically and/or educationally disadvantaged students each year to complete a paraprofessional program. The grant is for \$200,000 each year for 3 years.

<u>SBIRT</u>

This state funding opportunity was offered to implement Screening, Brief Intervention and Referral to Treatment (SBIRT) services in community health centers. After discussion the options, the health centers decided this was not an opportunity they thought NCHC should pursue.

Elaine Bussey made a motion to NOT submit an SBIRT grant; Charlie Cotton seconded the motion. Motion passed. Sharon Beaty and Adele Woods abstained. Bi-State Navigator Grant

At this point, Bi-State is waiting to hear confirmation from CMS about their Navigator funding. They have asked if NCHC plans to enter into another agreement for this work. NCHC will continue Marketplace work without the agreement with Bi-State through New Hampshire Health Plan and HRSA.

Gail Clark made a motion to NOT enter into a new contract with Bi-State; Kristina Fjeld-Sparks seconded the motion. Motion passed. Sharon Beaty and Adele Woods abstained.

Strategic Planning - Goal: "Increase NCHC Messaging about Value-Added Strategies"

Tony Poekert facilitated a SWOT analysis of the goal. Results of the discussion will be incorporated into the updated strategic plan document.
