# **Consent Agenda**

# July 2012 Financials

There was discussion about whether or not the financials should be included on the consent agenda. It was decided that financials will continue to be on the consent agenda unless the finance committee recommends otherwise. # **Policy Review**

There was discussion about HIPAA policy and what is required for NCHC as it relates to Molar Express and North Country ACO. Nancy Frank will check with Robin Fisk to find out which type of HIPAA policy we should have and who we should have Business Associates Agreements with.

### **Grants Update**

*HNH Foundation*: NCHC is preparing a grant proposal in response to an RFP to plan and implement 8-10 screenings of a documentary on obesity around the state. NCHC plans to collaborate with Southern NH AHEC. The budget will be around \$10,000.

NCHC was awarded \$165,000 from the NH Charitable Foundation for Substance Abuse Prevention Network programming.

NCHC is working on the operational funding proposal to the Neil and Louise Tillotson Fund which is due October 1<sup>st</sup>.

### **Molar Express Update**

Ed Shanshala has gotten the go-ahead from his board to transfer the van to NCHC. Once he has the title we will move forward. Ed also has some portable equipment that Ammonoosuc Community Health Services purchased a few years ago. NCHC has money in the new outreach grant to purchase some of the equipment and will look into it further.

The NH State Oral Health Program was awarded a HRSA grant to focus on oral health workforce development. Molar Express, Ammonoosuc Community Health Services, and Mid-State were all written into the grant to receive funds to develop the training pipeline. Funds will assist with development of fixed sites and expansion of Molar Express.

NCHC is in the process of hiring a new Dental Hygienist. Ashley Croteau resigned; she got a job at the new prison in Berlin.

#### North Country ACO Update

On August 22<sup>nd</sup>, the ACO board, several NCHC board members, and the regional hospitals held a meeting facilitated by Kevin Stone from Helms and Company. It was a productive meeting that focused on building a collaborative atmosphere as the ACO work grows. The hospitals would like to meet regularly. We will schedule those dates now and look into funding options if we want Kevin to facilitate additional meetings.

#### **Annual Meeting**

The board would like to invite Steve Rowe, new president of the Endowment for Health, to speak at the annual meeting. Two dates were proposed – November 9<sup>th</sup> and November 13<sup>th</sup>; Nancy will see when Steve is available. Robin Fisk will also be approached to see if she will speak. Elaine Bussey and Roxie Severance offered to help plan the annual meeting.

### **Nominating Committee**

Nominating committee will be Roxie Severance, Tony Poekert, Sharon Beaty, Ed Shanshala and Bob Fink; Tony will chair.

The by-laws state that the board should have no less than 9 members, and not more than 21 members.

### **Membership Committee**

Invoices for 2012 membership will be sent with a "save the date" notice for the annual meeting. Membership Committee members are Bob Fink, Roxie Severance, Ed Shanshala – Tony Poekert will chair the committee. Membership Committee would like to propose a fee structure at the October board meeting.

Nancy Frank will set up nominating and membership committee meetings.

### **Other Business**

New member application from Michelle McEwen from Speare Memorial Hospital Sharon Beaty made a motion to approve the application from Speare Memorial Hospital; Alisa Druzba seconded the motion. Motion passed.
