The letter will be sent to the Governor and the Executive Council. Nancy will draft the letter and send to Charlie, Maria and Gail for review before sending out.

## **Grants/Funding Update**

- NCHC will receive about \$130,000 through a contract with Bi-State Primary Care Association for Marketplace Navigator services.
- NCHC received \$25,000 from the Office of Rural Health Policy for Marketplace Outreach and Education.
- The New Hampshire Health Plan has released an RFP for Marketplace Outreach and Education activities. NCHC would like to partner with Mid-State Health Center to apply for these funds. *Adele Woods made a motion move forward with this proposal; Margo Sullivan seconded the motion. Motion passed. # North Country ACO Update
